He has published "The Impact of Human Rights Law on Armed Forces" (2006, Cambridge University Press) and; "Defence: The Legal Implications: Military Law and the Laws of War" (1987, Brasseys) and has edited "The Gulf War 1990-91 in International and English Law" (Routledge and Sweet & Maxwell, 1993) and (with D.McGoldrick & E.Donnelly, "The Permanent International Criminal Court: Legal and Policy Issues" (Hart, 2004). He has given papers in Norway, USA, Sweden, Germany, Holland, Poland, Ukraine, Moldova, Russia, Australia, Trinidad and Tobago and the Cayman Islands.
